AMENDMENT TO MOTION TO LIMIT NOTICE

1. Paragraph 6 of the Original Motion is Deleted and the following Paragraph is substituted in lieu thereof:

2. Paragraph 9 of the Original Motion is Deleted and the following Paragraph is substituted in lieu thereof:

3. The WHEREFORE paragraph is deleted with the following paragraph being substituted in lieu thereof:

“WHEREFORE, the Trustee respectfully requests that notice of settlements of all adversaries in this case be limited to the parties listed on Exhibit A: the parties having made an appearance in the adversary in which a settlement is sought; and, with the motion and notice of compromise settlement to be posted on the web site located at www.natlassoc.com as maintained by Dan Hopper.”

4. The balance of the motion remains unchanged.
