FINAL MOTION FOR PAYMENT OF EXPENSES OF ATTORNEY FOR TRUSTEE

COMES NOW the Plaintiff in the above-captioned case and hereby moves that this Court approve the payment Plaintiff's attorney in this action, stating to the Court the following:

1. On the 16th day of March, 1999, the undersigned was authorized to pursue preference actions on behalf of the Trustee.
2. The terms of that engagement provided that the undersigned would receive one-third of the proceeds, plus out-of-pocket expenses. The undersigned has filed a separate Motion for Payment of Attorney Fees for the last adversary proceeding in which the estate has received a payment of a preferential transfer. The undersigned has previously filed three applications for reimbursement of out of pocket expenses. The undersigned hereby makes application for the unpaid out of pocket expenses associated with the third application for payment of expenses that was filed and mailed on September 10, 2003 and refilled and re-mailed on December 30, 2003 as it had been lost in the court's electronic filing system. 4. The total expense reimbursement requested by Joseph A. Peiffer is \$795.60.

WHEREFORE, Plaintiff respectfully requests that this Court enter an order directing the Trustee to forthwith pay the undersigned attorney out of pocket expenses in the amount of \$795.60 and grant such other and further relief as the Court deems just and equitable, given the circumstances.
